



## Doris J. Fair

August 10, 1938 - April 27, 2022

Doris J. (Switzer) Fair, of Parker, known as Jeannie to some, passed away on Wednesday, April 27th, 2022, surrounded by her family, from complications of a 10-year battle with breast cancer. She fought fiercely right up to the end. Born at home on August 10, 1938, at the Cratty Building in Parker, PA., she was the daughter of the late Thomas Russell Sr. and Elsie (Dunkle) Switzer. She married Virgil E. Fair on June 15, 1956, in Petrolia, PA. He preceded her in death on June 17, 1996.

Doris was active in her community. She served as tax assessor for Licking Township for 20+ years and was an Election Poll worker for many years. She was also a member of the Callensburg/Licking Township Ladies Auxiliary, holding the position of President for several years.
